Sub: Implementation of U-DISE+ in States and UTs

Respected Na'am/Sir,

As you are aware, UDISE data was collected from schools through offline UDISE Software till 2017-18. Under that setup, the data was fed manually at the school level in Data Capture Format (DCF) of U-DISE as on the cutoff date of 30th September of each year. The information under U-DISE was collected from each school once in a year.

2. From 2018-19, it has been decided to launch the UDISE+ (i.e., UDISE plus) application, so that it becomes an effective tool for decision making. The entire system is online and will gradually move towards collecting real-time data. The new software will have the following additional features:

- A **Dashboard** for visualization and presentation of complex data in a simple form with standard as well as query based reports and comparative charts.
- Link to GIS mapping** which will have various attributes of schools like exact geographical location of school with latitude & longitude, school category, school management, infrastructure status, etc.
- Third party verification** to ensure data quality. A mobile app will also be developed for this purpose.

3. As you are aware, an orientation cum training programme was held for the MIS coordinators of States & UTs in the third week of January 2019 and the DCFs & the online software were shared with the participants. On the basis of suggestions received during the training, the DCFs have been revised accordingly. In order to facilitate data entry and usage by schools of different categories, 18 Data capture Formats (DCF) have been developed based on category of the schools.

4. The UDISE+ application (udiseplus.gov.in) has been developed and launched by NIC and all the 18 DCFs in PDF format are uploaded on this website. The DCF pre-populated with 2017-18 data will be generated by the software based on the school category and data entry can be done through any of the following modes:

- Online for all UTs: All schools in all UTs including Delhi and Puducherry shall upload data directly on the UDISE+ software.
- For other States, schools that have internet access have to provide data directly in the online UDISE+ Software. Schools that do not have any internet access have to fill the physical DCF provided by Block Resource Coordinator (BRC)/Cluster Resource Coordinator (CRC). The Block MIS Coordinator shall feed the data of all such schools online using the UDISE + software.



(iii) The States and UTs which are collecting data using their own software will be allowed to share the data in any of the following digital mode:

- (a) Through Web Services
- (b) Through Database Backup (CSV or PostgreSQL Database Dump)

However, these States and UTs will also need to comply with basic features of UDISE+ and comply with all the requirements specified in the Instructions.

5. As you would appreciate, that data quality and accountability is of utmost importance. Hence, it has been decided that the respective officers/agencies shall be personally responsible for correctness of the data for the schools under their jurisdiction, and provide a certificate to that effect, which may be properly recorded.

6. The Performance Grading Index launched by the Department includes 70 indicators, of which source of data for almost half the indicators is UDISE. UDISE+, in addition, includes 10 PGI indicators. Hence the grading of the State/UT will to a large extent depend on the data provided in UDISE+. Also, this data will be used for PAB meetings for different schemes. Hence, it is necessary to ensure that the data provided is correct and comprehensive.

7. State/UT level User Name and Password for the UDISE+ software will be created and communicated by SMS on receipt of details as per the proforma enclosed (Annexure-I). States and UTs have their own codes for School Management, Social Category and Type of Teacher. Codes being used along with the Parent ID to which the same is to be mapped may also be provided as per the enclosed format (Annexure-II). 
8. Another round of orientation cum training workshop will be held in the 2nd week of March. Therefore, you are requested to kindly depute the persons handling UDISE at State/UT level for the said workshop. The TA/DA of the participants shall be borne by their respective State/UT. The officers who attend the workshop shall train the district level officers handling UDISE who in turn shall train all the block level officers. The block level officers shall train the CRCs and school teachers.

9. The following timelines may be adhered to for providing and validating data in a timely manner:-

SI No.	Activity	Date of Completion
1.	Training, translation, and dissemination of DCF formats to all schools	By 31 st March, 2019
2.	Filling up of DCFs by all schools in either physical or electronic or online format and 100 % checking by CRCs	By 30 th April, 2019
3.	Blocks to submit data of all schools online to the district level after validations, sample checking and certification	By 31 st May, 2019
4.	District to submit data of all Blocks online to the State level after validations, sample checking and certification.	By 15 th June, 2019
5.	States to submit data of all districts online to the national level after validations, sample checking and certification.	By 30 th June, 2019
